

^{Luke 6:2-6} So the Twelve Disciples called a meeting of all the believers in the area. "We should spend our time preaching, not administering a feeding program," they said. ³ "Now look around among yourselves, dear brothers, and select seven men, wise and full of the Holy Spirit, who are well thought of by everyone; and we will put them in charge of this business. ⁴ Then we can spend our time in prayer, preaching, and teaching." ⁵ This sounded reasonable to the whole assembly, and they elected the following: Stephen (a man unusually full of faith and the Holy Spirit), Philip, Prochorus, Nicanor, Timon, Parmenas, Nicolaus of Antioch (a Gentile convert to the Jewish faith, who had become a Christian). ⁶ These seven were presented to the apostles, who prayed for them and laid their hands on them in blessing.

- 1. Who was Stephen?
- 2. How was Stephen described? _____

As the Gospel began to be preached to the non-Jews (Gentiles), the numbers of believers grew in and around Jerusalem. The Jewish were called Hebrews; the non-Jewish believers were called Hellenists.

Luke 6:1 Now, in those days, when the number of the disciples (believers) was multiplying, there arose a complaint against the Hebrews by the Hellenists, because their widows were neglected in the daily distribution. (Provisions for daily care needs)

3. What were the Hellenist believers complaining about?

The Hellenists believers were not Jewish; most of them spoke Greek. The Hebrew believers were Jewish; they spoke Hebrew or Aramaic. The 12 disciples could not keep up with the needs of all the believers, so they asked the believers in the church community to select 7 men to focus on ministry to the Hellenists. STEPHEN WAS ONE OF THE 7 SELECTED; ALL SEVEN MIGHT HAVE BEEN GREEK-SPEAKING HELLENISTS TOO.

- Acts 6:7 Then the word of God spread, and the number of the disciples (believers) multiplied greatly in Jerusalem, and a great many of the priests (religious leaders) were obedient to the faith.
 - 4. What happened after the 7 men were added to the ministry team?

Acts 6:8-10 And Stephen, so full of faith and the Holy Spirit's power, ^[a] did spectacular miracles among the people. ⁹ But one day some of the men from the Jewish cult of "The Freedmen" started an argument with him, and they were soon joined by Jews from Cyrene, Alexandria in Egypt, and the Turkish provinces of Cilicia, and Asia Minor. ¹⁰ But none of them was able to stand against Stephen's wisdom and spirit.

- 5. __Yes __No Stephen was a brilliant preacher, but the unbelieving, religious leaders could not handle nor would receive the truth he was sharing.

- 7. __Yes __No Did Stephen do anything wrong? He was preaching about Jesus.

<u>A Slight Review</u>

- Acts 6:9 The religious leaders argued with him publicly and openly.
- Acts 6:10 They were jealous & humiliated by the wisdom of Stephen.
- Acts 6:12 They stirred up the crowd to turn against Stephen.
- Acts 6:12 They physically brought him (seized) to the authorities
- Acts 6:13 Stephen was accused of speaking blasphemous words against God.
- Acts 6:58-59 They threw Stephen out of the city and stoned him to death.

10. __Yes __NoNotice, that while Stephen was dying, he was talking to God. Would it
ever be possible to forgive someone without God's help?11. __Yes __NoNotice, that while Jesus was dying, he was talking to God. Isn't it
logical that we forgive that offending person since we don't know the
whole story. God has a plan that involves both people.
